High quality, diagnostic radiographs are a very important part of patient care. For dental radiographers to be effective, they must understand radiation. This includes radiation history, physics, image characteristics, effects, and risks. Dental radiographers must be skilled in their technique and understand why dental images are necessary for diagnostic purposes. They also need to understand how to protect themselves and their patients. Additionally, dental radiographers need effective communication skills to gain trust with their patients. When people are educated, they are more likely to cooperate. This course will cover a wide range of basics of radiation, as well as exposure techniques for both intraoral and extraoral dental radiographs. Patient relations and education will be discussed to help dental professionals manage challenging patients. The duties and responsibilities required of all dental radiographers will be reviewed.
